The Meeting of the Connecticut Health Insurance Exchange Board of Directors was called to order at 1:30 p.m.

A. Call to Order and Introductions

Lt. Governor Wyman called the meeting to order at 1:30 p.m. Lt. Governor Wyman then requested Board members to identify themselves.

B. Executive Session

Lt. Governor Wyman requested a motion to go into Executive Session to discuss matters exempt from disclosure under C.G.S. 1-200(6)(A). Motion was made by Roderick Bremby and seconded by Robert Tessier. ***Motion passed unanimously.***

Lt. Governor Wyman requested a motion to reconvene the Special Meeting of the Board of Directors. Motion was made by Vicki Veltri and seconded by Robert Tessier. ***Motion passed unanimously.***

C. Reconvening

Members of the public were invited back into the Special Meeting at 2:44 p.m.

Lt. Governor Wyman requested a motion to appoint Jim Wadleigh to the position of Acting Chief Executive Officer of the Connecticut Health Insurance Exchange. Appointment shall be effective for the period to commence on the first day following the last day of office of the current Chief Executive Officer, Kevin J. Counihan, until such time as a Chief Executive Officer shall be appointed by the Board of Directors and take office. During the above interim period, the Acting Chief Executive Officer shall perform all the duties and have all the powers of the Chief Executive Officer. Motion was made by Robert Tessier and seconded by Benjamin Barnes. ***Motion passed unanimously.***

Lt. Governor Wyman requested a motion to appoint the membership of the Human Resources Committee and the Chair of the Board of Directors as the Executive Search Committee for the purpose of selecting the Chief Executive Officer of the Connecticut Health Insurance Exchange. Motion was made by Robert Tessier and seconded by Vicki Veltri. ***Motion passed unanimously.***
